New Business:

1. Approved a resolution to ammend the Dodgeville recreation project deleting the restrooms and utilities on a motion by Dorvinen seconded by Kangas. Poll vote - yes - Moyle, Dorvinen, Wisti, Kangas, Becia, Raffaelli and Bingham. Motion carried.

2. The state police purchased 18 acres of land off of the Haapapuro Road for \$38,000 to construct a tower and also 40.08 acres off of the Luoto Road in the Tapiola Area for \$40,000 for a second tower. No Action taken by the Board.

3. Answers to the Febuary 9th letter from Koivisto and Tesanovich. Wisti made a motion to have the Febuary 9th letter opposing the land swap between the State of Michigan and Lake Superior Land Co. published in the Gazette and Lanse Sentinal editorial page seconded by Kangas. Poll vote - yes - Moyle, Dorvinen, Wisti, Kangas, Becia, Raffaelli and Bingham. Motion carried.

4. Dorvinen made a motion to approve spring clean up for May month and to call for the dumpsters seconded by Moyle. Poll vote - yes - Moyle, Dorvinen, Wisti, Kangas, Becia, Raffaelli and Bingham. Motion carried.

5. Houghton County Road Commission - checked on applications sent in for funding of the Green Acres Road also read a letter from Tom Moyle stating that he would contribute \$4,350 and stated that when his mine rock depletes he would develope the property into residential sites. Tabled any further action at this time.

6. Wisti made a motion to approve an ammendment to the water purchase agreement with Adams Township to include Dakota Heights and to approve the agreement for fourty two years seconded by Dorvinen. Poll vote - yes - Moyle, Dorvinen, Wisti, Kangas, Becia, Raffaelli and Bingham. Motion carried.

7. Dakota Heights project was held up a bit until permission was obtained to make cuts in M-26. Bid opening will be the end of April.

9. Checking into having Mike Wilmers approved by the state as the building inspector.

10. Moyle made a motion to purchase the copy machine from Sayen at a cost of \$3,623.00 seconded by Dorvinen. Poll vote - yes - Moyle, Dorvinen, Wisti, Kangas, Becia, Raffaelli and Bingham. Motion carried.
